# **Vehicle Stickers**


All Vehicles on Continental Village Properties (Parking Lots & overflow spaces,) must have a Vehicle Sticker or they will be subject to towing.

Wildlife: We all like to feed the birds, however we are experiencing problems with rodents. We do live by wetlands, and we are going to have visitors from time to time. Please keep in mind when you put out an excess amount of bird seed it will attract visitors such as skunks, opossums, mice, & rats. They feed on the seeds as well.

#### PREVENTATIVE MEASURES BEING TAKEN TO KEEP OUR **COMMUNITY SAFE!** Please read the following message from the **CVOA Board of Directors:**

The communities surrounding CVOA property have been noticing an increase in rodents and unwanted pests. Please find comfort in knowing that our community is staying ahead of this potential Front Porches Replacements problem by having the professionals assess our property and locate

potential areas they feel will best help to keep the rodents and pests

The information below should answer any questions you may have about the method used and the locations:

\*In every court a black box with a medium size hole on one side have been placed.

\*These boxes are created to be CHILD and PET RESISTANT ONLY. \*The box is meant to house a poison typically used to kill unwanted pests.

# \*Please keep your children and pets away from the boxes.

There have been several dog incidents in the community, while children under the age of 18 (Waukegan Ordinance) are not able to handle the pet. You must be able to control your pet if you come upon another dog. They might start fighting and kids do not know how to handle this situation. Dogs have been injured.

# Code of Ordinance for the City of Waukegan Pets

Sec. 4-41. - Pets shall be restrained, no running at large.

An owner shall keep and maintain his pet under restraint; provided, however, that this section shall not apply to a dog being used for rescue or law enforcement work. It shall be unlawful for an owner to allow the pet to cross outside the property line of its owner, including reaching through, over or under a fence, or to keep or allow his or her pet to be outdoors on in an unfenced portion of the owner's property, unless the **pet is leashed and** under the control of its owner or another responsible person over 18 years of age
